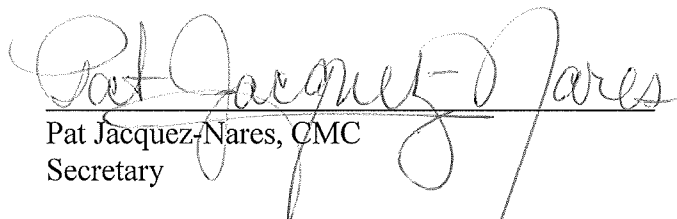
AMERICANS WITH DISABILITIES
