CONFERENCE WITH LEGAL COUNSEL -- ANTICIPATED LITIGATION (One case).

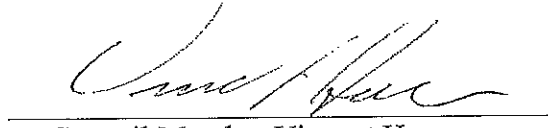
