ORAL COMMENTS FROM COUNCIL

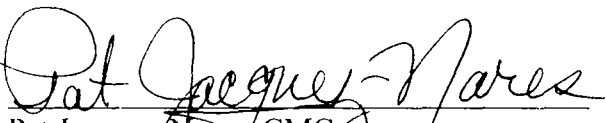
Mayor Pro Tem Holloway stated that both he and the Mayor attended Lenny Arreola's funeral service on Saturday. He thanked staff that also attended.
