A Special City Council Meeting of the City of La Puente was held in the Council Chambers of City Hall, 15900 East Main Street, La Puente, California, on October 23, 2013, at 6:00 p.m.

CALL TO ORDER

Mayor Klinakis called the meeting to order at 6:02 p.m.

Mayor Klinakis thanked Mr. Lomeli for being available to the City. He also stated that Mr. Lomeli's resume was very impressive and it was what the City needed at this time.

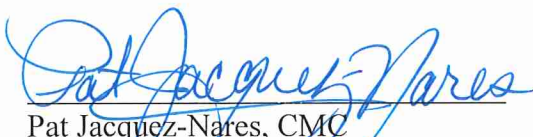
ORAL COMMENTS FROM STAFF
