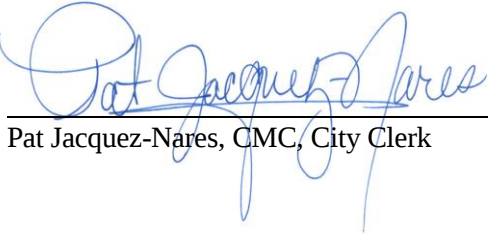
MEETING TIMES
