SM-1 CONSIDERATION OF A RESOLUTION PROVIDING FOR APPOINTMENTS TO THE OFFICES THAT WERE TO BE ELECTED ON TUESDAY, NOVEMBER 5, 2024, AND CANCELLING THE CITY'S NOVEMBER 5, 2024, GENERAL MUNICIPAL ELECTION

SM-2 DISCUSSION AND DIRECTION REGARDING RESOLUTION NO. 24-5872 REQUIRING CITY COUNCIL APPROVAL FOR ANY DISBURSEMENT OF FUNDS ALLOCATED TO THE CITY COUNCIL FOR COMMUNITY NEEDS DURING A CAMPAIGN PERIOD AND SUSPENDING THE CITY MANAGER'S AUTHORITY TO ACCEPT, CONSIDER, OR APPROVE INDIVIDUAL COUNCIL MEMBERS REQUESTS FOR THE DISBURSEMENT OF FUNDS ALLOCATED TO THE CITY COUNCIL FOR COMMUNITY NEEDS OF \$4,000 OR LESS DURING A CAMPAIGN PERIOD (COUNCIL MEMBER ARGUDO/MAYOR QUINONES)

City Attorney Altamirano provided a report regarding Resolution No. 24-5872, in light of the City Council's adoption of Resolution No. 24-5894, cancelling the City's November 5, 2024, General Municipal election.

In response to an inquiry from Council Member Mendoza regarding discretionary funds, City Attorney Altamirano confirmed that amounts less than \$4,000 would go through the City Manager and amounts above \$4,000 would be brought to the City Council for consideration.

City Manager Lindsey spoke regarding the Comedy Night in the Park hosted on August 17, 2024, and thanked Staff for their hard work and support.

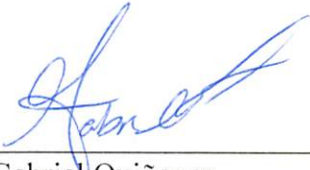
ADJOURNMENT
